### INTRODUCTION TO CIS

The Construction Industry Scheme (CIS) was introduced by the Government to set rules about how payments are made for construction workers.

We introduced CIS to help contractors that wish to provide services under the construction sector, or that are already working within CIS. By engaging with us as a CIS sub-contractor, you can benefit from typical tax rates of 20% (subject to individual circumstances) without the burden of endless paperwork.

There are specific rules that HMRC expect CIS workers to follow. ICS work alongside you to ensure that you are abiding by these rules and are here to assist with any questions that you may have.

# HOW TO REGISTER FOR CIS

#### Use the Construction Industry Scheme (CIS) online service

Sign up or log in to file your monthly returns as a CIS contractor, or to verify a subcontractor.

Online services may be slow during busy times. Check if there are any problems with this service.

- Register for self-employment with HMRC
- You will then be sent a Unique Tax Reference (UTR)
- After you receive your UTR, call HMRC to register for CIS (you will need your National Insurance Number for this)
- Once complete call ICS on 0800 195 3750

\*Note if you are already registered for CIS, simply call us with your UTR number so that we can assist you straight away.



### **HOW TO SIGN UP TO ICS**

Signing-up to ICS is simple. Call us free on 0800 195 3750 where we can complete your joining form over the phone. We will require:



- A copy of Identification (I.E passport)
- Agree to checks being made with the UK border agency (if applicable)
- O Copy of right to work in the UK Your UTR Number
- Your VAT number (only if registered)
- You will be required to enter into a self-employed contract

We will ask that you complete an assessment over the phone, which is a predetermined set of open ended questions that are analysed to determine whether you are subject to (or to the right of) supervision, direction and control (SDC) and are legally self-employed.

After we have verified your details with HMRC we can then commence paying you. Our team of experts can also help with any questions you have regarding CIS.

REMEMBER being CIS registered, HMRC will require you to complete a Self-Assessment Tax Return. Failure to complete these on time can result in HMRC penalties. ICS have in-house qualified accountants who can complete this for you for just £100 +VAT!

## WHAT IS SDC?

#### Supervision

Is someone supervising your work?

**This means:** Someone is watching over you/overseeing the work you do. Does someone need to help you to develop your skills or knowledge?

This doesn't mean: being briefed at the start and end of the day (but you can do the work yourself)





#### **Direction**

Is someone making you do your work a certain way?

**This means:** you are given instructions and advice on how the work has to be done as you may not necessarily have the expertise


This doesn't mean: being advised on safety standards (but you are still competent to complete the work on your own)

#### Control

Is someone telling you how and where to do your job? Could they move you?

This means: someone tells you exactly how to do your work and can move you depending on their priorities (i.e. one day you are on the railways, the next day a labourer)

This doesn't mean: a safety advisor telling you not to work on the railway lines at certain times (this is expected)
